1. CUSTOMS CONTROL AND DECLARATION:

All travelers are subject to Customs control, including both the individual and his/her belongings (Supreme Decree No 016-2006-EF). The Customs Authority is empowered to examine travelers and/or to inspect their baggage or packages.

The responsible family member may provide only one declaration form per family group when traveling accompanied by his/her parents, spouse, and/or children under 18 years old.

2. ITEMS EXEMPT FROM CUSTOMS DUTIES:

Items that travelers may reasonably need during their trip and that due to their nature and quantity are not presumed to be used for commercial purposes. The following items are exempt from customs duties:

Traveler's personal effects:

Clothing and adornment items; toiletry; medicines; 01 unit or 01 set of sport items; books, magazines and printed documents; 01 portable electronic hair device; 01 shaver or electric razor (*);

Other portable items for traveler's personal use:

- •01 musical wind or string instrument;
- •01 broadcasting receptor or sound reproduction device, even with a recorder or equipment containing them and up to 20 compact discs;
- •01 conventional or digital camera;
- •01 non-professional video camera (*);
- •01 DVD player:
- Up to 10 photographic films; 01 external hard drive for computer; 02 memory cards for digital camera, video camera and/or videogame, only if you carry these devices with you; 02 USB flash drives (pen drive); 10 videocassettes for portable video camera; 10 digital disks for video or videogames;
- •01 electronic domestic videogame;

- 01 electronic agenda or tablet (*);
- 01 computer with its own energy source (*);
- 02 mobile phones (*);
- 01 electronic calculator:

Cigarettes and Liquors: Travelers over 18 years old are allowed to enter up to 20 cigarette packages or 50 cigars or 250 grams of cut tobacco or tobacco fiber for smoking, and up to 03 liters of liquor.

Pets: 01 live domestic pet that shall be authorized by SENASA upon arrival.

Disabled or ill travelers: Auxiliary means and equipment necessary for traveler's medical control and mobilization.

Other items: Items for traveler's personal use or consumption and gifts which due to their quantity or diversity are not presumed to be used for commercial purposes, which total value does not exceed US\$ 500.

(*)Only for travelers over 7 years old.

3. ITEMS SUBJECT TO CUSTOMS DUTIES:

Travelers may bring into the country other items not included in the above list which value does not exceed US\$ 1,000 per trip and up to US\$ 3,000 per calendar year, for which they shall pay a fee of 14% over their Customs value; provided that due to their quantity, nature or diversity, they are not presumed to be used for commercial or industrial purposes.

4. RESTRICTED OR PROHIBITED ITEMS:

In order to bring restricted items (agricultural, wildlife, and cultural heritage products, weapons and ammunitions, etc.) into the country, travelers must obtain appropriate authorization from the relevant entity. Not declaring these items upon their arrival or departure may result in administrative and/or penal sanctions. Items not allowed to be brought into the country include: used clothing and footwear not considered as part of the traveler's baggage, foreign beverages named "Pisco", among others, which will be subject to seizure.

5. OBLIGATION TO DECLARE CURRENCY AND/OR MONETARY INSTRUMENTS:

Currency and/or monetary instruments over US\$ 10,000 (ten thousand U.S. dollars) or its equivalent in another currency must be declared. Failure to declare will result in seizure without prejudice of administrative and/or penal actions (Art. 28° and 31° in the 27693 Act, Financial Intelligence Unit). For such purpose, travelers must request SUNAT – ADUANAS a written evidence of their declaration.

6. TEMPORARY ACTIVITIES:

Travelers are allowed to temporarily enter to our country the following items for up to 12 months prior presentation of Entry/Temporary Exit Declaration and a bond deposit for an amount equivalent to import taxes: tools and equipments necessary for professional or technicians' activities that come to provide services, provided they are able to be identified and individualized. A non-resident traveler is allowed to temporarily enter sport items to perform activities related to adventure tourism without a bond deposit. To regularize Temporary Operations, a traveler must appear before the Customs authority with due anticipation before leaving the country.
